RULES FOR APPLICATION

- * Applications will be processed only after receipt of the non-refundable Registration fees (Rs.1000)
- * The Application must be **made by the person herself** and **NOT by proxy**. If allotted a stall, she **MUST BE PRESENT** in the stall for the complete duration of the Exhibition.
- * Selected participants are prohibited from exhibiting or conducting private shows in Mumbai—whether wholesale or retail—within 30 days prior to the event. This restriction also applies to participation under any alternate brand name too. Breach of rules will lead to cancellation of the stalls with NO REFUND.
- * NGO's must send their Application with Product photos, Registration fees and copy of NGO Certificate. The Committee will decide whether or not to allot them a Complementary stall. Your application MUST have a name and Mobile number for communication.

APPLICATION FORM:

- *Applications sent through google form must have your Look Book / a PDF copy & Registration fee details attached or duly filled in.
- *Applications sent by courier or hand delivered (to Ruchika Club Office) to have Application form accompanied by Registration fee Rs. 1000/- (non-refundable) in cash or cheque drawn in favour of RUCHIKA CLUB. Please mention your name and mobile number behind the cheque. A minimum of 6 colour photos —size 6"x 8" / Look Book or Catalogue of the Brand's latest collection, must accompany the Application Form. The Applicant's name and product price must be written behind each photograph. Organizers will retain the photos. No colour xerox will be accepted.
- * Applicants needing LARGER SPACE can request for combination of 2 sizes.
- * **DONOR STALL** details will be sent on request after they send their Application Form and lookbook. Donors get to choose stalls before allotments are done and are a part of our promotions.
- * No individual intimation is sent for receiving Applications. No phone calls will be entertained concerning the same.
- * Incomplete applications will be REJECTED without any revert

LAST DATE FOR SUBMISSION OF FORMS – 10th February, 2026

DATES FOR SCREENING:

- * Screening of products will be held in February & March. Applicants will be informed individually about exact time & date.
- * **Products exhibited** at stall must be **similar to those shown at screening**. No product can be added without prior permission of Organizers.

PARTICIPATION & CANCELLATION RULES:

- * **Confirmations** will be sent to chosen participants individually with terms of payment, and participation fees which MUST be completed by the date mentioned to retain allotment.
- * No refund is made if a stall is cancelled under any circumstance OR breach of rules.
- * In the event of cancellation due to force majeure or any govt. ruling 10% will be deducted and the balance refunded.
- * Last date for sending final replies to all applicants from our end by email 30th April, 2026
